## LANDOWNER PERMISSION FORM

Whereas:

The members of the Lunenburg Snow Riders, an affiliate member of the Snowmobile Association of Massachusetts, recognize the inherent risks of the sport, and do accept that anyone who drives or rides an OHRV shall not maintain any action against an owner, occupant or lessee of land for any injuries which result from such inherent risks, dangers or hazards in accordance with the Massachusetts Landowner Liability Laws. and Whereas the Massachusetts General Laws state:

**PUBLIC USE OF LAND FOR RECREATIONAL, CONSERVATION, SCIENTIFIC EDUCATION AND OTHER PURPOSES;  
LANDOWNER & APOS'S LIABILITY LIMITED; EXCEPTION (MGL: Chapter 21: Section 17C) See attached.**

Landowners who lawfully permits the public to use such land for recreational use without imposing a charge or fee therefore who leases such land for said purposes to the commonwealth or any political subdivision thereof or to any nonprofit corporation, trust association **shall not be liable for personal injuries or property damage** sustained by such members of the public, including without limitation a minor, while on said land in the absence of willful, wanton, or reckless conduct by such person.

Landowners are not required to post their property against OHRV use. The absence of signs prohibiting OHRV's does not imply that OHRV's are welcome or allowed. However, Landowners may designate the area for use, by posting reasonable notice of such designation, if so desired. Landowners are not responsible to keep their land safe for use by others who may hunt, fish, trap, camp, hike, sightsee or operate OHRV's.

### LANDOWNER PERMISSION

Written landowner permission is required to operate an OHRV on private property. OHRV Clubs and the Bureau of Trails may obtain verbal permission from landowners for public OHRV trails. OHRV operators must stop and present identification to a landowner when requested to do so,

and Whereas:

The Lunenburg Snow Riders, its members and affiliates have agreed to accept the dangers inherent in the sport and have agreed to hold harmless and not maintain an action against any owner, occupant or lessee of land for any injuries which result from such inherent risks, dangers or hazards while operating on private property, and will respect Landowners specific policies and rules, and will treat the land as if it were our own,
